DELCO'S WARRANTY POLICY

MANUFACTURER'S LIMITED WARRANTY

Delco Trailers, LLC warrants that its product, operated by the original purchaser under normal use and service, be free from defects in material and workmanship for a period of 1-year from the date of original sale subject to requirements, exclusions, and limitations stated below. Upon the purchase of a Delco Trailers, LLC trailer, the purchaser agrees to the manufacturer's Limited Warranty, which is accompanied with the purchase of a new trailer. The purchaser agrees that he/she has been informed of the Limited Warranty and claim procedures and will perform all responsibilities under this Limited Warranty.

WARRANTY COVERS

This 1-year Limited Warranty on Stock and Cargo Trailers and 2-year Limited Warranty on Utility, Flatbeds, and Dumps covers the structure portion of the trailer. Which includes the frame, consisting of fenders, crossmembers, side post, exterior walls, roof of rails, bows, and the sub frame. Furthermore, Delco Trailers, LLC warrants its paint application to be consistent with industry standards for 1-year after date of original purchase, with the exception of normal wear conditions and deterioration due to factors such as chipping, scratching, fading, cracks in caulk seams, road sat or tar, damage by animals or pressure washers.

WARRANTY EXCLUSIONS

Tires, axles, brake components, springs and suspension components, couplers, jacks, castors, mats, batteries, windows, doors, and any other auxiliary parts purchased and installed by Delco Trailers, LLC are warranted by their manufacturer and are not included in this Limited Warranty.

WARRANTY VOID

This Limited Warranty covers only defects in original components due to normal use and will be void if product is subject to accident, misuse, negligence, tampering, overloading, improper attachment, or improper maintenance. Normal wear items including but not limited to, flooring, paint, brake linings and bearings will not be replaced due to wear. Loading in excess of gross vehicle load ratings stated on the certificate will invalidate all warranties. This Limited Warranty excludes all liability for consequential or incidental damages. This Warranty does not cover a product which has been repaired, altered, or tampered with outside of the factory of Delco Trailers, LLC in any way without written approval by Delco Trailers, LLC. If a trailer has been rented or used for commercial hauling, this Limited Warranty is null and void.

LIMITATIONS

The sole responsibility of Delco Trailers, LLC under this Limited Warranty shall be to repair and replace parts at the Delco Trailers, LLC factory, an authorized Delco Trailers, LLC dealer, or another location with prior approval by Delco Trailers, LLC. Any repairs performed at a location other than Delco Trailers, LLC will be granted \$65.00 per hour for labor costs. Delco Trailers, LLC holds the right to refuse excessive charges for labor costs. Transportation of any trailer to and from your Dealer or an approved repair facility shall be the responsibility of the trailer owner. All other obligations or liabilities including incidental or consequential damages, or contingent liabilities arising out of the failure of any parts to operate properly are hereby excluded, including but not limited to any damages resulting from loss of use, inconvenience, loss of time, commercial loss or any type of damages, general or specific, foreseen or unforeseen, unless applicable state law provides other-wise.

All implied warranties of merchantability and fitness for intended use are limited to warranty periods stated above unless any applicable state law provides otherwise.
